Volunteer Agreement

Agreement between:

Corfu Angel Cats, located in Kastellanoi Messis, Corfu, Greece

and

[Volunteer Name]

(hereinafter referred to as "the Volunteer") residing at Corfu Angel Cats, Kastellanoi, Corfu.

1. Purpose

Volunteering with Corfu Angel Cats is not simply to have a holiday in Corfu, but a responsible commitment to the care and protections of living beings, requiring dedication, reliability, responsibility and genuine cooperation.

This agreement outlines the terms and conditions of volunteer service between Corfu Angel Cats and the Volunteer. The Volunteer agrees to provide voluntary services to Corfu Angel Cats in accordance with this agreement.

2. Scope of Volunteer Services

The Volunteer agrees to perform the following services as required for Corfu Angel Cats:

- Cleaning cat enclosures
- Feeding cats
- Socialising cats
- Medicating cats
- Assisting with adoption events
- Gardening
- Any other activities to promote the work of Corfu Angel Cats.

The tasks will be performed within approximately five hours a day, six days a week.

3. Term of Service

This agreement shall commence on the date of the Volunteer's arrival and shall continue until the date of the Volunteer's departure. The Volunteer and/or Corfu Angel Cats may terminate this agreement at any time if its terms are violated.

4. Volunteer Responsibilities

The volunteer agrees to:

- Adhere to all Sanctuary policies and procedures.
- Comply with all safety guidelines and wear appropriate safety gear when required.
- Maintain confidentiality regarding all Sanctuary information, including donor information, cat medical records and other sensitive information.
- Represent Corfu Angel Cats in a professional and courteous manner at all times.
- Report any concerns or issues regarding the health and wellbeing of the cats to the management
- Attend any required training sessions.
- Avoid use of drugs and alcohol while in the Sanctuary.

5. Corfu Angel Cats Responsibilities

Corfu Angel Cats agrees to:

- Provide the Volunteer with necessary training and supervision.
- Provide the Volunteer with appropriate safety equipment when required.
- Maintain a safe and healthy work environment.
- Provide the Volunteer with opportunities for development.
- Acknowledge and appreciate the Volunteer's contributions.
- Provide basic accommodation.

6. Insurance and Liability

The Volunteer acknowledges that their volunteer services are performed at their own risk. Syros Cats shall not be liable for any injuries or damages sustained by the Volunteer while volunteering at Syros Cats. The Volunteer is responsible for obtaining and maintaining their own personal insurance coverage. A valid (within the last ten years) tetanus vaccine is required.

7. Required documentation

The Volunteer must provide a copy of identification card or passport, letters of recommendation if possible, and reference contact information for background checks. We also need a proof of the health insurance.

8. Indemnification

The Volunteer agrees to indemnify and hold harmless Corfu Angel Cats, its directors, employees, and volunteers from any and all claims, losses, damages, liabilities, and expenses (including attorney's fees) arising out of or resulting from the Volunteer's negligence or wilful misconduct while volunteering at Corfu Angel Cats.

8. Acknowledgement

The Volunteer acknowledges that they have read, understood, and agreed to all the terms and conditions of this agreement.

9. Modifications

This agreement may be modified in writing by mutual consent of both parties.
